

Regulations of stay in Houseboat Modern 11

Conditions of stay

Houseboat Modern 11 located in Marina Yacht Park in Gdynia at Rybickiego 4c. hires a client on the basis of a reservation made on portals [booking.com](https://www.booking.com) and Airbnb or website www.casamare.pl. Determination of the date and amount of rental. The customer can use the houseboat with the entire amount of the rent.

On the day of download keys or on the day of the stay the customer will pay a deposit of 500 PLN with handling fee, which will be returned to the customer on the last day of your stay. If any damage occurs or technical losses in equipment, the deposit will be deducted. After this time, the customer is given a copy of the accounts, bill and made a settlement deposit.

Minor damage to the technical condition of the houseboat as well as desired losses in its equipment are refundable in case of settlement. If any damage occurs or technical losses in equipment, the deposit will be deducted. After this time, the customer is given a copy of the accounts, bill and made a settlement deposit.

The subject of the lease is a Houseboat, which may be desired that to be used mainly for the purpose of use only as a tourist. It shall be communicated on the first day of the rent for 16.00 PLN useful for the use, technically, complete with equipment.

Issue occurs on the basis of download keys from the box and read of the above rules.

Client obligations during the period of the lease keep the Houseboat in the same state as intended.

Refund of the deposit is laid on the condition during handover, ie. Technically efficient, clean, complete with equipment. Putting in a state other than the existing authorized desired present rents ± lying to understate the return of the deposit with min. 250 PLN.

Houseboat is insured for IDP.

In case of accident or other damage was founded than the time covered including Najm I, client obligations ± tied to the insurance policy, which is drawn up in the form of mail, but ± foundations lying ± for the customer to occur ± accession for compensation to the insurance company.

The customer is liable for material damage to the houseboat with equipment desired components in the period covered by including Najm.

For stealing desired email client during the stay, The customer and the owner does not respond.

If desired if the damages qualify ± a claim to liquidation in the field of insurance, it stops a claim until the compensation from the insurer. Participation in the cost of own damage in the load until a claim customer.

Risk of injury, damage to the houseboat and its equipment desired down load AZ and a client from the moment of release, to the time of the transfer.

This risk is not applicable to a glass bed, which will be ± coated (Optional L Acone) for plant with Example insurance with the COG owner contained with policies of Insurance ±.

Without the consent of the customer and the owner, the customer can not make changes in equipment and design houseboat.

The customer can not use the houseboat in the sublease.

In a rented Houseboat can not stay more persons than desired declared when booking. If this number is exceeded, the deposit is forfeited.

In Houseboat can not be kept animals. This being of animals results in forfeiture of security deposit.

For damages result that the animal corresponds to the customer.

On the client rests Obligatory relationship should maintain desired sharply desired no follow the rules of safety and IDP.

In Houseboat and on the terrace there is a whole meadow total ban on smoking.
